ภาคผนวก ก.

เนื้อหาของแถลงการณ์ร่วมระหว่างพรรคเสรีนิยมประชาธิปไตย พรรคสังคมนิยมญี่ปุ่น และพรรคแรงงานเกาหลีเหนือ เมื่อวันที่ 28 กันยายน ค.ศ. 1990

1. The three parties acknowledge that Japan shoul extend a thorough and official apology to, and provide compensation for, the Democratic People's Republic of Korea for the unhappiness and plight it caused the Korean people for 36 years in the past and for losses suffered by the Korean people in the 45 years following the end of the waar.

Liberal-Democratic Party President Toshiki Kaifu, in a personal letter to President Kim Il Sung, acknowledge the existence of an unfortunate past, which Japan caused vis-a-vis Korea. In his message, he made it clear that he, as prime minister, shares the same feelings as former Prime Minister (Noburu) Takeshita, who in March 1989 in the Diet expressed deep remorse and regret over the unfortunate past, Kaifu furthermore expressed hope that his actions will help improve relations between Japan and DPRK.

House of Representatives Member Shin Kanemaru, head of the LDP delegation, apologized deeply for Japan's past colonial rule over the Korean people.

The delegations of three parties acknowledge that Japanese government should not only establish diplomatic relations (with the DPRK) but also provide sufficient compensation (for the DPRK) for the damage which Japan caused the people of DPRK in the past.

- 2. The three parties acknowledge that the two countries should resolve the abnormal situation existing between the two countries and establish diplomatic relations at an early date.
- 3. The three parties acknowledge that two nations should promote exchanges in political, economic and cultural fields in order to improve bilateral ties. Moreover, satellite communication and direct air links should be established between the two countries.
- 4. The parties acknowledge that Korean residents in Japan should not be discriminated against and their human, ethnic and legal rights should be respected. The three parties acknowledge that the Japanese government should guarantee the rights of Korean residents in Japan by law. The three parties also note that Japanese authorities see the need to eliminate the clause in Japanese passport as regards the DPRK (that prohibits visits to the DPRK.)
- 5. The three parties acknowledge that Korea is one and that the peaceful reunification of North-South through dialogue is in the best interests of the Korean people.
- 6. The three parties note that it is necessary to make joint efforts toward creation of a peaceful, free Asia and to make every part of the earth free from the threat of nuclear obliteration.
- 7. The three parties agree to strongly urge their government to enter into intergovernmental negotiations in November of this year with the aim establishing diplomatic relations between Japan and the DPRK and settling various pending issues.

8. The three parties agree that, in line with the wishes of the peoples of Japan and the DPRK - and in the interests of peace in Asia and the world - relations between the Liberal-Democratic Party and the Korean Workers' Party and those between the Japan Socialist Party and the Korean Workers' Party should be further strengthened and mutual cooperation should further be developed.
